

## **iDonate June Bank Holiday Fundraiser Competition – TERMS AND CONDITIONS**

### **The Promoter:**

The Promoter is iDonate Ltd., Galway Road, Tuam, Galway, H54 TX47 (the “Promoter”)

By entering this competition all entrants agree to be bound by these terms and conditions and any other conditions in the messaging or promotions of this competition (which may be amended at any time by iDonate Ltd.). Any entries not complying with these terms and conditions will not be valid. The terms and conditions herein are governed by Irish Law and the parties submit to the exclusive jurisdiction of the Irish Courts.

- All fundraisers who set up a fundraising page on [www.idonate.ie](http://www.idonate.ie) for the VHI Women’s Mini Marathon 2023 event, or the Cork City Marathon 2023 event, and **raise over €100 online through their iDonate online fundraising page, are** automatically entered into the draw.
- A minimum of €100 must be processed online through an iDonate.ie fundraising page to be eligible for the competition.
- Donations processed outside of iDonate.ie are not eligible for competition.
- Only fundraising pages set up for the VHI Women’s Mini Marathon event (taking place Sunday 4th June 2023) or the Cork City Marathon event (taking place Sunday 4th June 2023) are eligible for this competition.
- Competition closes **June 30<sup>th</sup> at 11.59pm**. Only fundraising pages with €100 raised at this time are eligible for the competition.
